#### **Bylaws:**

The TOC bylaws were amended, bringing them into line with "traditional practices." *See below.*

Amend the Bylaws of the Tamworth Outing Club as follows:

Article I A (2) to read: Family Member. To include spouse, parent, or child (two votes per family).

Article III A to read: Board of Directors. The Board of Directors (the "Board") shall be composed of not more than fifteen (15) elected voting Members (the "Directors"), including the Club Officers.

Article III D to read: Election of Officers. Directors and Officers will be chosen by ballot of the Members at the annual meeting of the Club and shall hold office for a term of two (2) years, or until their successors are chosen. [delete second sentence]

Amend the first sentence of Article IV to read: Nominating Committee. At a regular meeting of the Directors, the Board shall elect three (3) Members including a Chairperson to serve on a Nominating Committee.

Amend the second sentence of Article V (Board of Directors' Duties and Meetings) to read: Regular meetings of the Board of Directors shall be held on the last Monday of each month from September through July.

The foregoing amendment was adopted by a two-thirds vote of the members in attendance at the annual meeting of the Tamworth Outing Club held on August 15, 2021 at 5:00 pm at Chocorua, New Hampshire.
